

Know Your Rights: Resources for Immigrants

CAIR-MA does not handle immigration cases. But we also know that the new Administration's harsh policies are making many Muslim immigrants fearful. Fortunately, several Massachusetts and national advocacy groups have created "know your rights" materials to help you prepare and protect yourself. The list below starts with general information, followed by ICE arrests, and then information for parents, employers, public schools, and homeless shelters. We have only noted where materials are available in languages that Muslim immigrants are likely to speak, although most materials are available in Spanish and sometimes other languages.

GENERAL INFORMATION
